The notation '[NP]' in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).

1. **Rules:** The race will be governed by the rules as defined in the Racing Rules of Sailing.
2. **Sailing Instructions:** The Sailing Instructions will be posted on the Club's Race Notice Board and available on the club web site no less than 48 hours prior to each race.
3. **COMMUNICATION**
 - a) The online official notice board is located at [Barrington Yacht Club](#).
 - b) [DP] All boats shall carry a VHF radio capable of communicating on [72 and 16](#).
 - c) On the water, the race committee may make courtesy broadcasts to competitors on VHF channel 72.
 - d) [DP] From the first warning signal until the end of the last race of the day, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.
4. **Entries and eligibility:**
 - 4.1. The race is open to all mono-hull sailboats
 - 4.2. Boats must have a 2021 PHRF-NB rating certificate,
 - 4.3. Crew size is limited to two individuals, including skipper.
 - 4.4. At least one of the persons on board must be a member of the Barrington Yacht Club.
 - 4.5. This is a non-spinnaker race.
 - 4.6. Use of autopilots or other auxiliary means of steering or propulsion is prohibited.
 - 4.7. Eligible boats may enter by completing the entry form and waiver attached by 1430 hours on June 16, 2021, for the June race, and by 1430 hours on September 8, 2021 for the September race
5. **Fees:**
 - 5.1. The entry fee is \$25.00 for each race.
 - 5.2. The skipper will be billed for the entry fee, unless the crew is the only club member on board, in which case the crew will be billed.
6. **Schedule:**
 - 6.1. First Warning Signal
 - 6.1.1. 1830 hours.

6.1.2. If there is more than one class, the starting order and class flags will be described in the scratch sheet to be available NLT 1500 on the day of each race.

7. VENUE

7.1. The races will be held in the Northeast quadrant of Narragansett Bay.

8. Courses:

8.1. The race committee will select a course using individual mark letters from Appendix A of the 2021 Tuesday night Cox Series.

8.2. Mark letters shall be posted in the order in which marks are to be rounded.

8.3. The race committee may, as a courtesy, broadcast the courses on VHF channel 72. A boat shall have no right to redress concerning the broadcast of courtesy information or lack or timeliness of same.

9. Penalty System: The penalty system in Rule 44.1, as modified by Rule V1, will apply.

10. Scoring:

10.1. Scoring will be in accordance with Appendix A

10.2. There will be one race in June and September.

10.2.1. The two races are **not** related with regards to scoring.

10.3. The corrected time for each boat, adjusted for PHRF time-on-distance, shall determine her finishing score.

10.4. There *may* be multiple classes in this race, depending on entries received.

11. Prizes

11.1. Prizes will be awarded for the top two OR three finishers, depending upon fleet size.

11.2. If there is more than one class, the top three finishers in each class will receive awards.

I am aware that the activities may involve maneuvering a boat or other watercraft in deep waters in potentially hazardous conditions which may include, without limitation, cold water and/or air temperatures, strong winds and currents, high waves, sudden and unexpected immersion in deep waters and collision with other watercraft or stationary objects such as docks, pilings and buoys. I understand that I am responsible for my actions while I may be (a) participating in the Series and (b) on the grounds of BYC. I further hereby release and discharge BYC, and its respective officers, directors, agents, servants, volunteers, and employees, from any and all negligence, liability, damage, injury, loss, cost or expense, including reasonable attorneys’ fees, incurred by me and arising in connection with or as a result of my participation in the Series.
